### JTB Achieves GSTC Tour Operator Certification, Leading Sustainable Tourism in Japan

#### Prestigious global acknowledgment for commitment to responsible travel practices

JTB Corp., Japan's leading travel agency, has achieved the Global Sustainable Tourism Council® (GSTC) Tour Operator certification for the scope of the domestic tour operation. The certification, issued by Bureau Veritas, a GSTC-Accredited certification body, was awarded on November 1, 2024. This achievement aligns with JTB's mission to "foster peace and global interconnectedness through the creation of opportunities for meaningful human interaction," reinforcing the company's dedication to sustainable tourism practices that enhance cultural exchange and social enrichment.





#### ■ GSTC Criteria and Certification

The GSTC Criteria are the result of a worldwide effort to develop a common language about sustainability in tourism. There are currently two sets of Global Criteria for GSTC Certification — Destination Criteria for public policymakers and destination managers and Industry Criteria for hotels/accommodations, and tour operators. JTB was certified against GSTC Industry Criteria for Tour Operators which are made up of the four pillars of sustainable management, socioeconomic sustainability, cultural sustainability, and environmental sustainability. The GSTC Tour Operator certification by the GSTC-Accredited Certification Body guarantees that the operator has a sustainable tourism management system and takes sustainable operations following the GSTC Criteria.


#### **■**Comment from Mr. NG of Third-Party Certification Body Bureau Veritas
